

PETITION TO MODIFY DEED RESTRICTIONS FOR LOTS WITHIN SECTION TWO (2).
BRAES MANOR, CITY OF HOUSTON, HARRIS COUNTY, TEXAS

Restrictions at Issue: Lots Within Braes Manor, Section Two (2), specifically, Lot 19 in Block 1, Lot 16 in Block 5, Lots 1 through 22, both inclusive, in Block 8, and Lots 1 through 12, both inclusive, in Block 7 (the "Subdivision"), according to the description of said subdivision recorded at Volume 2826, Pages 82-87 of the Deed Records of Harris County, Texas, together with those maps or plats recorded or referred to in the above described Deed Records, including, but not limited to, those maps or plats recorded in Vol. 46, Page 30 of the Map Records of Harris County, Texas (the "Plats").

Current Deed Restrictions: Those recorded and set out in Volume 46, Page 30 of the Map Records and at Volume 2826, Pages 82-87 of the Deed Records of Harris County, Texas ("Current Deed Restrictions").

Purpose of Petition: The sole purpose of this Petition to Modify Deed Restrictions for Section Two (2), Braes Manor, City of Houston, Harris County, Texas (the "Petition") is to remove the one and the one and one-half story restriction for a single family dwelling on Lot 19 in Block 1, Lot 16 in Block 5, Lots 1 through 22, both inclusive, in Block 8 and Lots 1 through 12, both inclusive, in Block 7, in Braes Manor, Section Two (2) (hereinafter the "Restrictions Being Removed"), according to the map or plat thereof recorded in Volume 46, Page 30 of the Map Records of Harris County, Texas.

Compliance with the Current Deed Restrictions: Chapter 201 of the Texas Property Code states that a petition to modify deed restrictions must receive the approval of 75% of the owners of property in order to modify the Current Deed Restrictions. After the requisite number of approvals has been received, the Modified Deed Restrictions set forth below shall be effective immediately upon recording in the County Clerk's Records of Harris County, Texas.

Proposed Modification: Upon compliance with the Current Deed Restrictions, the following restrictive covenants (the "Modified Deed Restrictions") shall apply to said Subdivision by incorporation into the Current Deed Restrictions. The Modified Deed Restrictions shall run with the land, for all purposes, bind and benefit each owner of property in the Subdivision and their heirs, executors, representatives, successors and assigns, whether or not referenced in subsequent deeds.

ARTICLE I – MODIFIED DEED RESTRICTIONS

1. Paragraph (1)(a) of the Current Deed Restrictions is hereby deleted in its entirety and replaced with the following: "A single family dwelling of one, one and one-half or two stories may be erected on any lot in Section Two (2) in said Braes Manor, Section Two (2)."
2. For reference purposes only, the following is a comparison of the original Paragraph (1)(a) of the Current Deed Restrictions with the modified version of the same as set forth above:

"A single family dwelling of one, one and one-half or two stories may be erected on any lot in Section Two (2), ~~except that a one story single family dwelling only shall be erected on Lot 19 in Block 1, Lot 16 in Block 5, Lots 1 through 22, both inclusive, in Block 8 and Lots 1 through 12, both inclusive, in Block 7 in said Braes Manor, Section Two (2).~~"

ARTICLE II – SECTION 201 STATEMENTS

1. Owners who do not sign the Petition must file suit under Texas Property Code § 201.010 before the 181st day after the date on which the certificate called for by Texas Property Code § 201.008(e) is filed in order to challenge the procedures followed in extending, creating, adding to, or modifying a restriction.
2. Owners who do not sign the petition may delete their property from the operation of the extended, created, added to, or modified restriction by filing a statement described in the fourth listed category in Texas Property Code § 201.009(b) before one year after the date on which the owner receives actual notice of the filing of the petition authorized by Texas Property Code § 201.
3. Owners below and/or attached affirm that they own record title to property within the subdivision of Braes Manor, and the legal description and street address of the property of each signing owner appears herein or is readily available, if necessary.
